Educational Programs. Westmoreland has endeavored to makes its educational programming competitive with other local nature centers. Competitive in this respect refers to both cost per child, per program, quality of teaching staff and curriculum content. In fiscal 2020, 391 programs were offered with a total of 6,310 participants. In addition, 20 virtual programs were offered with 371 participants.

Westmoreland's challenge with the management of 640 acres is to focus its conservation and funding efforts on those habitats requiring immediate restoration, namely (1) Wheeler Field, a wet field habitat with an attaching shrub/woodland corridor, (2) Catbird Field, a dry field habitat, (3) Lost Pond Vernal Pool, a seasonal pond requiring monitoring, (4) Betchel Lake, a large open water wetland, and (5) Riparian Stream Habitat, a NYS regulated wetland
